AER History

Army Emergency Relief was founded in 1942 by Secretary of War Henry Stimson and Army Chief of Staff Gen. George Marshall. Charged then with relieving undue financial stress on the force, AER continues to serve the enduring priorities of the Secretary and Chief of Staff of the U.S. Army. Since 1942, AER has provided \$2 billion to nearly 4 million Soldiers, including \$1 billion since 9/11 through zero-interest loans, grants and educational scholarships. Almost all active-duty Soldiers and their dependents qualify for AER assistance, as well as military retirees; widows and orphans of Soldiers who died on active duty or after retirement; medical retirees and their Families; and members of the Guard and Reserve who are activated on Title 10 orders for more than 30 days.



1 2 5 4 3 World War I veteran and song writer Irving Berlin wrote the Broadway musical "This is the Army,"

which opened July 4, 1942, in New York's Broadway Theatre. It was the largest and best-known morale-boosting show of World War II. It raised more than \$2 million for the newly formed Army Emergency Relief. The following year, future President Ronald Reagan and Joan Leslie starred in the movie adaptation of the Broadway show.

Maj. Gen. James Ursano Scholarship Program for Military Children

AER awarded **\$9.7 million** in Ursano scholarships to more than **2,000** dependent children.

Retired Maj. Gen. James Ursano served as AER's sixth director from 1976 to 1986.

The Maj. Gen. James Ursano Scholarship Program for Military Children is based on applicants' financial need and was established to assist children of Soldiers in obtaining their first undergraduate degrees.

Applicants must be listed as dependents of their Soldier sponsors in DEERS and must be under the age of 24.

Applicants may receive assistance for up to four academic years but must meet eligibility criteria and reapply each year. The application cycle runs from January 1 through April 1 for the following academic year.

Award amounts vary each year based on the:

- ★ Number of applicants
- ★ Total approved scholarship budget
- Applicant's Expected Family Contribution (per Free Application for Federal Student Aid)
- Average cost of attendance to attend a college or university in the United States (per College Board)

Mrs. Patty Shinseki Spouse Scholarship Program

Mrs. Patty Shinseki served as a member of the AER Board of Managers for 20 years. In honor of her extraordinary service, the AER Board of Managers renamed the Spouse Education Program after her in December 2019.

The Mrs. Patty Shinseki Spouse Scholarship Program is based on applicants' financial needs and was established to assist spouses in continuing their educations.



Applicants are eligible to receive funding for up to four academic years of full-time study or eight academic years of part-time study. Scholarships may apply to trade and vocational schools as well. Applicants must reapply each year and may apply *year-round*.

Award amounts vary each year based on the:

- ★ Number of applicants
- ★ Total approved scholarship budget
- ★ Applicant's Expected Family Contribution (per Free Application for Federal Student Aid)
- Average annual cost to attend a college or university in the United States (per College Board)

Pentagon Victims Scholarship Program

AER provides several sources of financial support for the Families of Soldiers who were victims on Sept. 11, 2001. The Pentagon Victims Scholarship Program was created for the spouses and children of the Soldiers killed or injured in the attack on the Pentagon. The scholarship was established to ensure all dependent spouses and children had the opportunity to complete their college educations. AER has since extended this scholarship to provide funding for graduate degrees.

Retired Sgt.1st Class Chris Braman was severly injured when he helped recover victims of the Pentagon attack. He was subsequently awarded the Soldier's and Purple Heart medals for his actions. His three children, Courtney, Lauren and Miranda, are all recipients of Pentagon Victims Scholarships.

Through generous donations to AER, Courtney graduated with a master's degree in professional studies in integrated marketing communications from Georgetown University, Lauren is currently in a master's-acute care nurse practitioner program at West Coast University and Miranda completed a master's degree in applied data science from Syracuse University.

AER has awarded spouses and children with almost **\$3.9 million** in support.

Transition Assistance Career Skills Support Program

AER's Career Skills Support Program is named after its seventh and longest-standing director, retired Lt. Gen. Nathaniel R. Thompson Jr., who served from 1986 to 2005.

AER committed \$3 million in grants to support Soldiers approved for the Army's Career Skills Program. AER's support of the program further expands its commitment to the Army's No. 1 priority: ITS PEOPLE.



CSP allows retiring and separating Soldiers to participate in skills training during their transition periods to improve their civilian employment options.

AER transition assistance may be provided as a grant up to \$500 for participation in a local continental United States CSP, a grant up to \$1,500 for participation in a non-local continental United States CSP or a grant up to \$2,000 for Soldiers traveling from outside continental United States to participate in a CSP.

Transition assistance may cover costs related to CSP for:

- ★ all forms of travel
- ★ tools/supplies
- ★ initial rent/deposits

- ★ uniforms/business attire
- ★ temporary lodging/food
- ★ utility deposits

Jack Ritchie Distinguished Service Award







While assigned with Company A, 2nd Battalion, 27th Infantry Regiment, 25th Infantry Division, near Quan Dau Tieng, on Nov. 5, 1966, then-Capt. Foley's company was ordered to extricate another company of the battalion. His outstanding personal leadership under intense enemy fire during the

fierce battle, which lasted for several hours, inspired his men to heroic efforts and was instrumental in the ultimate success of the operation. He received the Medal of Honor on May 1, 1968, from President Lyndon B. Johnson.
